FAQ – Frequently Asked Questions

How do I know if I qualify for a card?

To qualify for the normal card you must be a resident, on the Padron of your local town hall and over 65 years of age.

To qualify for the gold card you must be a resident, on the Padron of your local town hall, be over 65 years of age and provide proof of income showing that your annual income is less than 75% of the minimum wage. (IPREM - Indicador Público de Renta de Efectos Múltiples).

What should I indicate in my application?

If you are applying for the normal card, simply enter your personal data and sign the application.

If you are requesting the Gold card, besides the above, you must also indicate your earnings over the past year. If you had no income you must indicate this on your application.

My partner has the Andalucía Tarjeta 65 card, can I use it?

No, the Andalucía Tarjeta 65 card is personal and not transferable. It can only be used by the person named on the card.

How long is the card valid for?

Five years after date of issue.

What does it cost to obtain the Andalucía 65 Card?

The card is free as well as any renewal.

I have received the card but the details on it are incorrect, what do I have to do?

You have to send it to the following address and include a letter explaining what is wrong.

I have the card in my name; to obtain any of the advantages do I have to present any identification documents?

Yes, you have to use the card together with your DNI or equivalent document.

What do I have to do in the case of loss or robbery of my card?

You have to write a letter including your personal details to the address indicated previously explaining what has happened.

Does the income of my partner have any influence on my application for a Gold Card?

No, the card is a personal document and so only takes into account your economic situation and not that of your partner.

What benefits does the Andalucía Tarjeta 65 give me?

With the card you can access services and exclusive discounts such as:

Apply for the Andalucían Tele-assistance service.

With discounts of 40%, 80% and up to 100%.

Currently the cost has been established at 18€ per month with discounts set at:

a) 100%: - Holders of the Andalucía 65 card, any type, over 80 years old and living on their own.

- Holders of the Andalucía 65 gold card, who live on their own or with other gold card holders.

b) 80%: - All other Andalucía Tarjeta 65 gold card holders.

c) 40%: - All other holders of the Andalucía 65 card not included in the sections above and persons with handicaps.
